

## Boundaries of the Ahupuaas of Kalihikai and Kalihivai.

Sir:

The undersigned owner of the Ahupuaa of Kalihikai, and of the major portion of the Ahupuaa of Kalihivai, both in Halelea District, Island of Kauai, T. H. hereby respectfully applies for a settlement of the boundaries of said Ahupuaas, and certificates of such boundaries.

The adjoining lands and owners so far as known to your applicant are:

Kalihikai,

On West side portion of the land of Hanalei, covered by Grant 4846

A. S. Wilcox, owner.

On East side the land of Kalihivai, owned by A. S. Wilcox.

On the North side bounded by the sea.

Kalihivai,

On West by land of Kalihikai owned by A. S. Wilcox, and by upper portion of Hanalei Govt. land.

On the South by Wailua, Govt. land, and by Kapaa Govt. land, Makee Sugar Co. lessee.

On the East by Kealia owned by Makee Sugar Co. Anahulu Govt. land, leased to Makee Sugar Co. Grants 2896 to C. Feterick, and Grant 630 to J. Rudoit, now Kilanea Sugar Co.

On the North by the sea.

Surveys of the lands of Kalihikai, giving boundaries as claimed by your applicant with maps to accompany said surveys are herewith enclosed.

Your applicant would therefore ask that a time be appointed for hearing on this application, and that the boundaries of said lands be settled and certified as by the enclosed surveys,

Brown Surveyor, and asking that the corrected survey be substituted for the survey received and filed on the 8<sup>th</sup> inst.

Appointed Friday April 14<sup>th</sup> at 10 Am. at the Court House of the District Court, Lihue, Kauai, as the time and place for hearing the said application; and caused notice of said hearing to be published in English in the Hawaiian Gazette Feb. 28, March 7, 14, and 21; and in Hawaiian in the *Huakaou* March 3, 10, 17, and 24.

Sent written notices of said hearing to the following owners or parties in interest in adjoining lands, viz: - Territory of Hawaii, per J. W. Pratt, Commissioner of Public Lands, Milauea Sugar Co. Make Sugar Co. Lihue Plantation Co.

Hearing of said application at the Court House Lihue at 10 Am. When present at the hearing the petitioner, Pineville Plantation Company, by W. O. Smith, its President, A. S. Wilcox, stockholder, W. O. Smith, Esq. also acting as Attorney for the Petitioner, Andrew Mow Esq. appearing for the Milauea Sugar Company, Fred L. Harvey, Esq., appearing for the Government, W. B. Rowell, Esq., L. J. Warren, Esq., and Jno. A. Palmer, as clerk. The application as originally filed by A. S. Wilcox was read, as was also the motion of A. S. Wilcox and Pineville Plantation Company, to amend said application, which motion was granted by the Commissioner, under which order said application was amended by the substitution of the Pineville Plantation Company as petitioner, in place of said A. S. Wilcox. The Commissioner announced that notice by order of the present hearing has been published, as required by the Statute, as follows: in the English language in the Hawaiian Gazette, on February 28, March 7<sup>th</sup>, 14<sup>th</sup> and 21<sup>st</sup>, 1905, and in the Hawaiian language in the *Huakaou* on March 3, 10<sup>th</sup>, 17<sup>th</sup> and 24<sup>th</sup> 1905, both of said papers being printed and published in Honolulu, Oahu.

L. J. Warren was sworn as stenographer.

The following persons were sworn and gave testimony touching the matter before the Commissioner, A. S. Wilcox, W. B. Rowell and Fred L. Harvey.

After hearing the evidence, and duly considering the same, the Commissioner confirmed the boundaries of Kalihikai and Kalihivai as described in the surveys, and as shown by the map of said lands filed by the petitioner with

Decision and Certificate of Boundaries.

On this 14<sup>th</sup> day of April, 1905, at Lihue, Island of Hawaii, in the Territory of Hawaii, I, Jacob Handy, the undersigned Commissioner of Boundaries for the Fifth Judicial Circuit of said Territory, having heard the petition of A. S. Wilcox, and the Princeville Plantation Company, an Hawaiian Corporation (as said petition was amended by leave of said Commissioner at said hearing) for the settlement of the boundaries of the Ahupuaas of Kalihivai and Kalihikai, in the District of Halelea, in said Fifth Judicial Circuit, Island of Hawaii, in accordance with the description and survey thereof as claimed by said petitioner, Princeville Plantation Company; And due and legal notice of said hearing been by said Commissioner duly given by advertisement as required by law; And said Commissioner having at said hearing received all of the testimony and proofs offered with respect to the boundaries of said lands; and also having received and considered as a part of the evidence in said matter, the testimony adduced in a certain proceeding for the settlement of the boundaries of said Ahupuaa of Kalihivai on November 22, 1877, before the Honorable Duncan M. Dryde, then Commissioner of Boundaries for said Fifth Judicial Circuit, (at that time the Fourth Judicial Circuit); and said Commissioner having endeavored to obtain all information possible to enable him to arrive at a just decision as to the boundaries of said lands; And at said hearing on said 14<sup>th</sup> day of April, 1905, the Kilauoa Sugar Company having been represented by

Andrew More Esq. and the Government of the Territory of Hawaii, having been represented by F. L. Army, Esq., Special Sub-Agent for the Commissioner of Public Lands, for the Island of Kauai, and Surveyor in and for the Survey Department of said Territory, and all persons and parties present and represented at said hearing having agreed to the settlement of the boundaries of said lands as in said application prayed and as hereinafter set forth and certified to:

Now therefore, I, said Jacob Hardy, Commissioner of Boundaries for the Fifth Judicial Circuit of the Territory of Hawaii, do hereby find from all of the evidence and facts before me presented at said hearing that the just and true boundaries of said lands are, and I hereby declare and certify them to be respectively, as follows:—

## Boundaries of Kalihiwai.

Beginning at the sea at the mouth of the stream called Niu, which is the North West corner of Grant No. 630 to J. Didoit, and running along said Grant 630 and Grant 2896 to L. Titcomb as described in said Grants by magnetic meridian:

1. S. 15° E. 660 ft. along foot of pali and Grant 630;
2. S. 25° E. 5280 ft. along Grant <sup>No.</sup> 630 passing between two rocks near the road to a marked Mala tree on the bank of the ditch called Kaluawiki which is the North West corner of Gr. No. 2896 to Charles Titcomb;
3. S. 20° W. 4884 ft. along Gr. 2896 to a marked Mala tree standing on North bank of Kilauca Stream;
4. S. 6° E. 14124 ft. along Grant 2896 to a peak called Namahana, and the foregoing boundaries being now shown on maps, by W. R. Monsanet, of Kilauca Plant on file in Govt Survey Office as Registered No. 1971 as follows:—

by true azimuth and distance:

1. 356° 40' 660 ft. along Gr. 630 J. Didoit to granite post.
2. 350° 40' 5280 ft. along Gr. 630 J. Didoit to granite post.
3. 12° 50' 3500 ft. along Gr. 2896 L. Titcomb to granite post.
4. 4° 25' 14120 ft. along Gr. 2896 L. Titcomb to peak called
