JUDGMENT.

An application to decide and certify the Boundaries of the Land
of Pohakuanu District of Hanalei Island of
Kauai having been filed with me on the 18 day of September
1873 by Edw. O. Hall.

in accordance with the provisions of an Act to facilitate the settlement of Boundaries, &c., approved on the 22d day of June, A. D. 1868; now, therefore, having duly received and heard all the testimony offered in reference to the said boundaries and having gone on the said land, at the request of

Henry S. ... agent for Government Lands and having endeavored otherwise to obtain all information possible to enable me to arrive at a just decision, which will more fully appear by reference to the records of this matter by me kept in Book No. 1, page 113, and it appearing to my satisfaction that the true, lawful and equitable boundaries, are as follows, viz:

The Boundary of this Land commences at a stone in the sea a short distance from the shore resembling a shark and called Pohakuanuano, thence up valley and ridge Kawaisapa to an old battle ground. Kalehua. Thence to Kahoi Thence to Kahoi Thence to Peah Alatala, the junction of this land with the Alupuaa of Kalalau Thence down along the Kalalau Boundary to a place called Puuki, Thence continuing down to a meeting place called

Kauakou thence down same ridge to a peak called Puuoia, thence down to flat called Keahupohaku thence to point on sea beach called Naupaka and thence round to place of commencement.

It is therefore adjudged and I do hereby decide and certify that the boundaries of the said lands are and hereafter shall be as heretofore set forth.
