JUDGMENT.

An application to decide and certify the Boundaries of the Land
of Koloa District of Koloa Island of
Kauai having been filed with me on the 28 day of May
1873 by Waldemar Knudsen

in accordance with the provisions of an Act to facilitate the settlement of Boundaries, &c., approved on the 22d day of June, A. D. 1868; now, therefore, having duly received and heard all the testimony offered in reference to the said boundaries and having gone on the said land, at the request of W. H. Rice & by order of the Circuit Court, and having endeavored otherwise to obtain all information possible to enable me to arrive at a just decision, which will more fully appear by reference to the records of this matter by me kept in Book No. 1, page 128, and it appearing to my satisfaction that the true, lawful and equitable boundaries, are as follows, viz:

The South East corner of this land commences on the sea beach adjoining the South West corner of the Government Land of Walewale at a place called Paapooko, thence along Walewale to a pile of stones at Kamukolea, thence to pile of stones Kamanomano, thence to pile of stones Kapueo, thence to pile of stones Kamaemae, thence to Puuhaakaa, thence continuing along Walewale Kaaua kakaa, thence crossing the Maaili road to the south bank of the Waikohou stream,

Thence along south bank of said stream to 3
stones. Thence crossing said stream and on
to a black rock on the south bank of the
aforesaid stream, Thence to top of small hill
called Kumamamane, Thence to top of a
conical hill called Puukahoanui, Thence
to top of Laukahi the North West corner of
Welewelu, Thence along top of Ridge bound-
-ded by Hairu to Omoi peak, Thence
from Omoi to Hoaea, Thence to the South
bank of Hulaia river, Thence following along
the southerly edge of said river to opposite
a round hill called Kauhula, Thence on
to the top of a high peak called Kahili the
North West corner of this land and North East
corner of Wahaua, Thence down along ridge
to Laukaihai, Thence down side of Lau-
kaihai across stream, and up to a plain
on ridge called Kalealea, the North East
corner of the land of Lawai, Thence along ridge
to top of Puukole, Thence down along Lawai
to Kahuamoa, Thence down along side of
Keke to red Bluff, Thence down side of
hill and across plain to the 2 mile stone on
the South side of the Government road, Thence
along Keke crossing gully to top of ridge
called Kamawou, Thence to large hole at Na-
mawana, Thence to Puukamalii, Thence to
Iron bolt in hole close to road way, Thence to
the easterly edge of a sandstone rock in the
sea and on the West side of Kuhuiula Bay

the South West corner of this land and South
~~West~~ East corner of Lawai and Reekew Thence
in an Easterly direction along the sea shore
to place of commencement.

It is therefore adjudged and I
do hereby decide and certify that the boundaries
of the said land are and hereafter shall be
as hereunto set forth.
